**Use procedures**

**SHAKE WELL BEFORE USING.**

Apply product with sponge or cloth to surface to be cleaned. Wipe surface. Use dry cloth to remove excess.

**Concentration**

Use **Citrikleen GR** as is or diluted up to 1 part product to 10 parts water depending on the amount of graffiti to be removed.

**Important**

**Citrikleen GR** may craze or soften certain plastics and may affect certain paints. Pretest on part to be cleaned before use.

### WAREHOUSING PRECAUTIONS

Store in a well-ventilated place. Keep container tightly closed. Keep cool. Store locked up. Do not store near heat, sparks, open flame, or other ignition sources. Do not store in direct sunlight. Avoid storing above 120°F (49°C).
