<b>Small parts cleaning</b>	Mix 1:1 ratio in bucket, use cold	Use cleaning brush, shop towel dry
<b>Oil spot removal from floors &amp; decks</b>	Mix 1:1 ratio in Penetone 191 sprayer and flood soiled area	Brush and rinse

## FIRST AID MEASURES
