**Citrikleen NST** is a biodegradable, water-soluble, heavy-duty cleaner/degreaser formulated with a natural hydrocarbon solvent and multicomponent surfactantemulsifier system to achieve superior cleaning and degreasing capabilities. **Citrikleen NST** contains no petroleum hydrocarbons, chlorinated solvents or ingredients listed by SARA Title III. **Citrikleen NST** outperforms many solvent, solvent emulsion and alkaline cleaners for removal of greases and oils while providing a safer, more pleasant environment.

**Citrikleen NST** will rapidly penetrate and lift the widest range of petroleum, animal and vegetable based oils, fats and greases, which are then easily removed by water rinsing. The oily contaminants in used **Citrikleen NST** solutions, when left in still tank or holding pond after cleaning, will rise to the top and separate. This oil may be removed by top skim-ming or by using the Citrikleen Surface Oil Vacuum Device.

Use procedure	S	
Parts washing	Cold tank cleaning—mix 1 part <b>Citrikleen NST</b> with up to 5 parts water. Soak for 5 minutes or longer. Rinse or wipe off.	
Oil, grimy surfaces	Cold ambient temperature—use concentrated or mix with up to 4 parts water. Pour or spray at low temperature and low pressure on surface to be cleaned. Permit to dwell for short period of time (5 minutes is usually sufficient). Rinse with water or wipe off.	
Tank Immersion Method	Mix concentrate with water at 1:4 to 1:10 depending on the degree of soil to be removed. For extremely heavily soiled surfaces, use concentrated or diluted up to 1:3 with water.	
Soiled, painted hard surfaces	1 part Citrikleen NST with up to 15 parts water. 4 gallons <b>Citrikleen NST</b> will give you up to 61 gallons of working solution. Wipe off with damp or dry cloth.

# **FIRST AID MEASURES**
