Use procedures

While the machine is running, pump **Pensolv LoVo L115C** from the holding tank and shower onto the wire or felt using a spray bar. **Pensolv LoVo L115C** can also be applied manually using a hand-held sprayer. Apply coarse spray directly to wire or felt under low pressure.

Concentration

Pensolv LoVo L115C is to be used full strength.

WAREHOUSING PRECAUTIONS
