May be used in combination with alkali, acid, and surfactant chemical cleaning or circulation procedures. Rinse procedure recommended.

Most effective when used undiluted.

Dilute to 2-5% v/v when used as part of a general chemical cleaning procedure requiring film removal. For removal of heavy deposition, use up to 18-25% v/v.

Ambient when used at concentrate. 65°C-70°C (149°F-158°F) recommended when used as part of chemical cleaning procedure.

5 to 30 minutes, according to the amount and depth of foulant. Monitoring and centrifuging of retains is recommended.
