Its rapid action and homogeneous wetting properties ensures constant and uniform removal of bulk deposits without localized pitting or corrosion.

DIRECTIONS FOR USE

Use procedure

Use TETRAGARD as part of a low-pressure application prior to a full wash procedure. Most effective when used with soft water. Scour or brush stubborn deposits.

Concentration

For low-pressure applications, such as canister-spraying, dilute to a maximum of 20% v/v with water, depending on the amount of deposits to be removed. Use undiluted for bulk scale removal procedures.

Use temperature

Cold water is recommended.

Dwell time / Operation time

Allow for complete removal of deposits before final rinsing.

Mechanical action

Low temperature, low-pressure application and rinsing recommended for removing stubborn deposits.

Rinsing

High pressure hot water
